Resource Provider Feedback

Meeting held 24th Jan with resource providers to solicit their feedback on the process/schedule with the following concerns presented:

- Resource Issues from the data:
 - MSINST group to support work outside of 12GeV beam transport is real and Dipette working with Oren on this
 - RF Elec Techs is fully loaded, but not a concern at this time
 - S&A: Difficulty planning Physics work (S&A) multiple people coming to C. Curtis from the same Hall
 - SRF labor is not leveled Anne can assist
- RPM Meeting has been a reporting meeting and not a problem solving/planning meeting
 - Even when Hall C tasks were discussed and planned for the upcoming month, a week later they were changed
 - 6 weeks out is the farthest the resource providers plan

Resource Provider Feedback (cont.)

Administrative Items:

- Some of the activities that spread the labor are not accurate reflections
 - We don't staff a person for 15 minutes a day over the duration of the activity
- We staff with crew sizes, multiple shifts (operators)
- % complete on resource graphs
- Remove the 100% completed activities from the resource sheets
- They like the new scope tagged in red font keep doing this
- Not all resource providers are on the distribution for the updated schedule
- Project managers have submitted work to the LSD, but their SPR (service provider request) is not in the system
- Account codes (not all are in the schedule), but some we are given do not exist
