

## 2016 SUMMARY ANNUAL REPORT

### For SURA/Jefferson Science Associates 401(k) Plan

This is a summary of the annual report for SURA/Jefferson Science Associates 401(k) Plan, EIN 54-1156453, Plan No. 003, for period January 1, 2016 through December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$4,618,549. These expenses included \$639,589 in investment fees, administrative expenses, and other direct costs plus \$3,978,960 in benefits paid to participants and beneficiaries. A total of 1,023 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$116,815,760 as of December 31, 2016, compared to \$101,104,043 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$15,711,717. This increase includes unrealized appreciation and depreciation in the value of plan assets. The plan had total income of \$20,330,266, including employer contributions of \$6,141,633, employee contributions of \$5,608,750, participant transfers from other retirement plans of \$1,279,542 interest and dividend and other earnings of \$940,425 and \$6,359,916 in net appreciation in the fair value of Plan investments. Total income of **\$20,330,266** less Plan expenses of **\$4,618,549** account for the **\$15,711,717** increase in net assets.
