

2011 SUMMARY ANNUAL REPORT

For SURA/Jefferson Science Associates 401(k) Plan

This is a summary of the annual report for SURA/Jefferson Science Associates 401(k) Plan, EIN 54-1156453, Plan No. 003, for period January 01, 2011 through December 31, 2011. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$673,408. These expenses included \$185,878 in investment fees and administrative expenses, and \$487,530 in benefits paid to participants and beneficiaries. A total of 924 persons were participants in or beneficiaries of the plan at the end of the plan year. While the Plan provides for 100% immediate vesting not all of these persons had yet earned the right to receive retirement benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$37,758,034 as of December 31, 2011, compared to \$24,539,515 as of December 31, 2010. During the plan year the plan experienced an increase in its net assets of \$11,218,519. This increase includes unrealized appreciation and depreciation in the fair value of plan assets. The plan had total income of \$11,891,927, including employer contributions of \$6,623,000, employee contributions of \$4,969,695, participant transfers from other retirement plans of \$211,925, other earnings of \$121,561 and \$34,254 in net depreciation of the fair value of Plan investments.
