Scope:

- Do program requirements meet the requirements of 10 CFR 851? Are they reasonable and adequate?
- Does the program address applicable consensus code requirements as required by 10 CFR 851? Is the program tailored with the requirements of the ASME Code?
- Does the program adequately address the implementation of measures to provide equivalent protection and ensure a level of safety greater than or equal to the level of protection afforded by the ASME Code
- Are program requirements excessive or has non-value added work been introduced?
